
TRULIEVE: THE TRUE REVENUE AND PROFIT LEADER OF THE FLORIDA CANNABIS MARKET

Trulieve Cannabis' dominance of the large and fast-growing Florida cannabis market along with its track record of rapid and profitable growth makes it one of the most fundamentally sound cannabis companies in the industry. Trulieve (TCNNF) is the undisputed leader in Florida's cannabis market where the company operates 31 dispensaries and offers home delivery for patients who cannot get to a physical store. Our analysis of data released by Florida's Office of Medical Marijuana Use (OMMU) shows that Trulieve owns ~20% of the total dispensing locations in Florida, the highest in the state. Even more impressive is that Trulieve's share of medical marijuana sales in the state is well above 50%, suggesting that the company's per store sales are much higher than peers like Curaleaf (CURLF), Liberty Health Sciences (LHSIF), Surterra, and others.

The company's leadership position in Florida is important since the Sunshine State is projected to be the third-largest legal cannabis market in the U.S. by 2022 with annual sales of more than \$1.7 billion, according to BDS analytics. Also, even though only medical marijuana sales are currently legal in the state, efforts are underway to put an amendment on Florida's ballot in 2020 to legalize recreational marijuana. If these efforts result in legalization of adult-use marijuana, they could expand the size of Florida's legal cannabis market to \$9 billion over the next decade, thus making it one of the biggest cannabis markets in the world and providing a huge competitive advantage to state leaders like Trulieve.

Trulieve's dominant market position is reflected in its best-in-class earnings – the company is one of the few operators in the cannabis industry that has been able to grow revenue at a fast pace without sacrificing profitability. In our May 23, 2019, cannabis industry primer, we highlighted how the current regulatory structure of the U.S. market favors state leaders that can build strong brands and capital-efficient operations over players that have a presence in a lot of states but do not dominate any of them. Trulieve fits the bill of an efficient state leader perfectly – driven by the legalization of smokable medical flower sales in Florida, the company's revenue jumped 30% q/q and 149% y/y to \$57.9 million in 2Q19, the highest among all U.S. cannabis companies. Profit growth was strong, too, with EBITDA surging 66% q/q and 166% y/y to \$31.6 million. Among all the players operating in the Florida market, Trulieve is the only one with a positive EPS on an annualized basis, confirming that top-line dominance is translating into profit leadership. The company expects to operate 44 stores in Florida by the end of the year and has guided for ~\$400 million in annual sales and ~\$160 million in EBITDA by the end of 2020. Despite strong and improving fundamentals, TCNNF's market cap has been falling due to the weak sentiment prevailing around cannabis stocks over the last few months. With an \$840 million market cap, TCNNF is currently trading at just ~5x CY20 EV/EBITDA. We believe the combination of a strong competitive position, solid fundamentals, attractive valuations, and a long growth runway (including expansion to other states like Massachusetts, California, and Connecticut) make Trulieve one of the best U.S. cannabis operators.

California marijuana market experiences license contraction in 2019. Before January 2018, when California launched its legal recreational cannabis market, estimates of how many dispensaries peppered the state's landscape were in the thousands. But once state licenses were required – and with that, express local city or county approval – the number dropped dramatically, to just a few hundred. The second contraction has taken place over the course of 2019, as temporary business licenses slowly expired. State regulators were required by law to stop issuing or extending temporary licenses as of Dec. 31, 2018. Read More (Marijuana Business Daily)




Chart 2: Number of Active Marijuana Business Licenses in California

The fight against unlicensed shops continues in the world's largest adult use market. Los Angeles city authorities raided and shut down an illegal cannabis dispensary in South Los Angeles as part of an effort to encourage only legal cannabis businesses to operate. The illegal dispensary had a green cross and green arrows on the building, indicating the operators made little effort to hide the nature of its business. USDA says hemp farmers now qualify for federal crop insurance. The U.S. Department of Agriculture (USDA) announced that hemp farmers operating under pilot programs authorized through the 2014 Farm Bill are now eligible for federal crop insurance for the 2020 planting season, while those who cultivate hemp under broader federal legalization in the 2018 version of the legislation can obtain coverage after regulations are developed. It's a very big subject and right now we are allowing states to make that decision," Trump said. "A lot of states are making that decision, but we're allowing states to make that decision." Cannabis industry contributions to state of Nevada cross \$100 million. Nevada's cannabis industry has broken the \$100 million dollar mark in taxes and fees for the first time. Dispensaries, cultivators, laboratories and producers have paid more than \$109 million in taxes and fees in fiscal year 2019. \$99.18 million was paid in taxes compared to \$74.7 million last year. For the next two years, the state is projecting more than \$100 million per year in tax collections. Cannabis sales were also up from \$529 million in fiscal year 2018 to approximately \$639 million in fiscal year 2019, an increase of \$110 million. Read More (Marijuana Retail Report)


Nevada judge gives OK for some new retail cannabis stores to open. More than a dozen new retail marijuana shops could open in Nevada in the coming weeks, after a judge gave the go-ahead to companies with owners who've all undergone background checks. Lawyers for the state and businesses suing over allegations that the licensing process was flawed said that about 16 cannabis dispensaries could qualify, mostly in the Las Vegas area. That will add to the 65 stores currently open statewide. Read More (Marijuana Retail Report)

Illinois licenses first five adult-use marijuana retailers. Illinois awarded its first licenses to businesses that can sell recreational cannabis when it becomes legal in the state next year. State regulators announced the five medical marijuana dispensaries where residents will be able to buy small amounts of recreational marijuana products starting Jan. 1. The first group of licensees are all owned by Chicago-based <u>Green Thumb Industries (GTBIF)</u>. Local recreational marijuana bans in Michigan could hurt legal sales. Nearly 40% of Michigan communities that approved a recreational cannabis ballot measure last year introduced local bans that prohibit retail sales, putting a possible damper on the adult-use market when it launches next year. Michigan's Marijuana Regulatory Agency issued emergency rules in July giving local authorities six months to introduce bans before regulators start to accept applications for business licenses November 1. Canada's cannabis industry output nears \$8 billion. Canada's legal cannabis industry output has doubled since the country legalized cannabis in October and has almost surpassed the black market in less than a year. Statistics Canada released updated monthly and Q2 GDP figures. Alberta squeaks out title as Canada's top cannabis market with \$123.6M sold. Statistics Canada has published new information on the amount sold at cannabis stores across the country, from legalization in October 2018 to June 2019. Alberta narrowly squeaked into the top spot with Ontario close behind at \$121.6 million, followed by Quebec at \$119.2 million.

A judge has ruled that New Mexico's medical marijuana program is open to people from outside the state who qualify based on medical condition. The final ruling responds to a petition by two Texas residents and the Arizona-based CEO of the largest chain of medical cannabis dispensaries in New Mexico in his capacity as a patient with post-traumatic stress disorder. Chicago to clear thousands of cannabis arrests during legalization. A nonprofit with the technology to analyze criminal records will help the county that includes Chicago clear tens of thousands of convictions for marijuana possession as Illinois gets set to allow the commercial sale of the drug. Illinois cannabis businesses face location challenges ahead of adult-use market launch. Under Illinois' adult-use cannabis law, the state's 55 licensed medical cannabis dispensaries can become licensed to sell in the recreational market, as well as seek licenses for additional retail locations—but some licensees have expressed concerns with the regulations, particularly when it comes to where they can set up shop. New York: New law reducing marijuana possession penalties takes effect. It also amends penalties for offenses involving the possession of more than one ounce but less than two ounces of cannabis from a criminal misdemeanor (formerly punishable by up to three months in jail) to a non-criminal violation punishable by a \$200 fine. We are nearing the end of cannabis prohibition if the history of alcohol regulation is any guide. One constant in history is the law of unintended consequences. 


Chart 4: Cannabis Metabolite Load Per Capita by City, March 2018 to February 2019

After breakout quarter, GTI looks to scale and optimize its 12-state footprint. Instead of targeting growth all over the map, Green Thumb Industries (GTBIF) is focused on growing its presence in its current 12-state footprint. In its 12 states, GTI has 31 open stores and another 60 stores in development. Out of necessity, the company is vertically integrated in a number of these states, with large scale production facilities. Fitch Ratings: Canadian banks steer clear of cannabis industry for now. Substantial risks in the cannabis industry, including increased compliance considerations and cross-border money laundering (AML) concerns, will continue to outweigh lending and advisory opportunities for banks in Canada and in the U.S. over the medium term, Fitch Ratings says. Canadian banks have shown reluctance to provide traditional banking services to licensed cannabis firms, notwithstanding the country's federal legalization nearly one year ago. Fitch expects that banks will remain cautious until the legal and regulatory standards are more established for cannabis on both sides of the border. Read More (Fitch Ratings)

CannTrust expected to be dropped by S&P/TSX index amid stock slide. It is another setback for beleaguered cannabis producer CannTrust (CTST) as the company is expected to be dropped from Canada's benchmark stock index this month. Its removal from the TSX Composite is likely to see large-scale index funds sell off their position in the company, which could result in as many as 4.8 million shares hitting the open market. Florida medical cannabis licensing issue heads to state Supreme Court. A court case that could break up Florida's vertically integrated medical marijuana structure and open up new licensing opportunities in the fast-growing market is headed toward the final step of a long legal process. A divided appellate court denied the state's request to rehear the matter, sending the case to the Florida Supreme Court for a potential review, the News Service of Florida reported. Judge: New Mexico must issue medical marijuana cards to nonresidents. A district judge in New Mexico made a final ruling ordering regulators to issue medical cannabis patient cards to qualifying out-of-state residents, but the governor's office said it will appeal. Michigan may require warning labels for cannabis health risks during pregnancy. 

USDA releases report on status of Canada's hemp industry. The U.S. Department of Agriculture (USDA) has published a report detailing the status of the legal hemp market in neighboring Canada. The six-page document from Agricultural Attaché Evan Mangino shows that while Canada legalized hemp about 20 years ago—with the U.S. moving to allow the crop under agriculture legislation enacted just last year—producers in both countries are facing similar regulatory challenges. Of the nearly nearly 5,400 metric tons of hempseed Canada exported last year, more than 70 percent went to the U.S., a figure that will presumably significantly fall going forward with large-scale domestic hemp farms expected to come online across the country by next growing season. State of the U.S. Hemp Industry: August 2019. The spot biomass market throughout August has been transacting in the range of \$2.73 to \$4.50 per percentage point of CBD content (/point) as supply from the 2018 crop year is sporadic and early season crops are being harvested. The trend of biomass selling near the lower end of the range has continued from July, as those who are holding product from the 2018 have incentive to sell before large quantities of product enter the market from the 2019 crop year. Is interstate hemp transportation actually legal? Federal court asked to sort it out. A Colorado hemp extraction company seeking the return of roughly 7,000 pounds of hemp biomass after it was seized in Idaho asked a federal court to override the state and affirm that hemp transportation is legal. But Idaho lawyers say the Colorado company – Big Sky Scientific of Aurora – "jumped the gun" when it shipped hemp through Idaho in January, a month after passage of federal legislation that guaranteed interstate hemp transportation. Nation's largest hemp processing plant opens in Colorado. Colorado City, a town of less than 2,500 in southern Colorado, will soon be home to up to 50 million pounds of hemp, now that a massive-hemp processing facility is open for business. Paragon Processing opened a 250,000-square-foot hemp-processing on August 29. Not only does the company say that the new facility is the largest of its kind in the country, but it could help bring 250 new jobs to Colorado before the end of the year, with a number of them located in Colorado City. Increases in state-issued hemp licenses. Passage of the 2018 Farm Bill sparked both sharp nationwide increases in licensing and explosive sales growth for 2019. The issuance of U.S. hemp-cultivation licenses saw a year-over-year, nationwide increase of 364% (from 3,546 in 2018 to 16,462 in 2019). In 2019, Tennessee led the trend with 3,200 new licenses, marking more than a 13x increase over its 226 in 2018. Conversely, Montana's comparatively low 277 licenses in 2019 represent nearly 40,000 acres, averaging a Big Ag-style footprint of more than 144 acres apiece. Read More (New Frontier Data)

EPA: Hemp pesticide approvals pending. Farmers have long-established practices for combating pests, diseases and weeds. They typically lean on years of experience, in addition to approved pesticides and herbicides proven to work for their particular crops. But the nascent U.S. hemp industry lacks similar tribal knowledge and regulatory guidance on these treatments to ensure healthy, productive crops. The U.S. Environmental Protection Agency recently took a step toward approving pesticide applications for hemp. The EPA announced it was seeking public comment on 10 applications from pesticide manufacturers to use existing pesticides on hemp. Read More (Cannabis Business Times)

USDA: Crop insurance available for some hemp growers for 2020 season. Federal crop insurance is finally coming to some hemp farmers as the U.S. Department of Agriculture (USDA) takes more steps toward adopting new rules for hemp production. This major health concern would wreak havoc on the cannabis industry's growth potential. Health dangers related to vaping may create the biggest obstacles for cannabis companies today. While the industry may want people to believe this was an isolated incident, there are still other problems related to vaping that appear more widespread. In just two months, there have been as many as 153 cases of respiratory illnesses related to vaping across 16 states. The first known death was in Illinois, where a patient who reported using e-cigarettes was hospitalized with severe respiratory illness and later died. The company plans to utilize the technology in the production of cannabis-infused beverages and other cannabis-infused products. Delta 9 Cannabis (VRNDF) announced that it intends to bring something to market that few other licensed producers have discussed – dry sift cannabis. Delta 9 anticipates to bring a product line, known as "Sapphire" to the market in the third quarter of 2019. With an estimated price per gram of \$30, the product is referred to as "dry sift cannabis" – also known traditionally as "kief" among cannabis users. Read More (the deep dive)

Chocolate edibles are vexing cannabis labs. Here is why. Chocolate, according to new findings out of California, can interfere with cannabis testing procedures and lead to inaccurate THC potency results. While the errors are small enough that they're unlikely to pose a threat to consumers, they reveal yet-to-be understood wrinkles in how potency testing works. CONSUMER AND SOCIAL TRENDS

Quality, potency, and intended effects are some of the most important criteria for consumers evaluating cannabis purchases. For consumers classified as versatile connoisseurs, who make up 10% of the Canadian adult population and consume cannabis on a daily basis, 96% rated quality as most important, 85% noted potency, and 84% rated intended effects as important criteria, according to a recent survey from EY Canada and Lift & Co. (LFCOF). 70% of current consumers who purchase in cannabis retail stores don't know which brand they want, or even what product they are going to purchase, before they enter a store, according to the survey. Despite the legalization of cannabis, the number of Canadians using cannabis has not changed over the past year. 4.9 million or 16% of Canadians aged 15 and older have used cannabis in the past three months, which is unchanged from the same quarter in 2018 according to the National Cannabis Survey for Q2 2019. Males are almost twice as likely as females to have consumed cannabis. Females also tend to get cannabis from family and friends rather than purchasing what they consume. 
RETAIL

Washington state may consider home delivery for small growers. The Washington State Liquor and Cannabis Board is pushing a bill that would allow cannabis home delivery for licensed growers operating less than 2,000 square feet of cultivation space. The long-in-the-works proposal is seen as a shot in the arm for small business owners struggling to compete with larger companies in the crowded Washington marketplace. As oversupply has driven prices down, the board is seeking ways to boost licensed growers' engagement with what quickly became a buyer's market in Washington. Read More (Cannabis Business Times)

Los Angeles opens next marijuana licensing round for 100 retail permits. Los Angeles, the largest marijuana market in the world, opened a two-week window for qualified social equity applicants interested in getting a retail cannabis permit. The city's Department of Cannabis Regulation (DCR) verified roughly 800 qualified applicants for the latest licensing round during a pre-vetting process that took over two months and finished in late July, according to the agency's website. Applicants that qualify for the city's social equity program will get priority in having their applications processed. Read More (Marijuana Business Daily)

Review of the results of the lottery for retail store licenses held by the Alcohol and Gaming Commission of Ontario. A total of 5,094 parties expressed interest, of which 4.5% were disqualified, withdrawn, or deemed incomplete. The remaining 4,864 applications entered the lottery across the five regions, with 42.2% of the applications submitted to open storefronts in Toronto or the Greater Toronto Area (GTA). From these applications only 0.9% were given the special email or call to congratulate them for being winners. Cannabis trial: Dutch cities picked for cafe supply experiment. Cannabis cafes in the Netherlands are to be supplied legally with drugs from regulated producers as part of a trial aimed at tackling the black market. Under Dutch law, cannabis can be sold over the counter in licensed coffee shops, but it is currently illegal to produce and supply the drug. From 2021, cafes in 10 cities will get a legal supply of "quality" cannabis as part of a four-year experiment. Read More (BBC)

Hemp fields in Poland continue a steady uptick. Polish hemp fields expanded to 1,500 hectares (3,700 acres) this year, with some farmers cashing in on total subsidies of €480 per hectare available if they farm organically. Polish farmers grew hemp on 735 hectares (1,800 acres) in 2016 and then expanded to 1,187 (2,950 acres) in 2017, the most recent previous year for which figures are available. Stakeholders say they expect hemp cultivation in 2020 could surpass 5,000 ha. (12,000 acres) as more and more players enter the market. Read More (Hemp Today)

Israeli health ministry approves seven new medical cannabis growers to battle market shortages. Seven new Israeli companies have received medical cannabis growing licenses under the country's new regulation, according to one person familiar with the matter who spoke to Calcalist on condition of anonymity. EU inspectors reportedly approve Uganda's medical marijuana for export. That's according to the Daily Monitor, which reported that a team of EU inspectors deployed from the Netherlands to the Ugandan capital of Kampala issued a certificate of compliance to Industrial Globus Uganda Ltd. The certificate, which is valid from August 6, 2019 to August 5, 2020, opens the door for the company to begin exporting its cannabis-based products. Read More (High Times)

Edibles lead Puerto Rico's wholesale medical marijuana sales. In recent months, cannabis-infused edibles have commanded one-third of wholesale medical cannabis sales in Puerto Rico – twice the average across a sampling of U.S. markets – and the category has room for more entrants. While orders have been strong, there are relatively few edibles brands in Puerto Rico, according to Ryan Smith, CEO and co-founder of LeafLink. "Puerto Rico is still a young cannabis market. We know edibles are a top category for retailers there, but as demand grows, there will have to be an increase in output from existing brands or supplemental output from new brands to keep up supply," Smith told MJBizDaily. Puerto Rico's medical marijuana program has undergone significant growth since sales began in January 2017. The latest release from the Puerto Rico health department shows a patient count of 92,499, meaning nearly 3% of the U.S. territory's population are registered medical marijuana patients. 


Chart 8: 2Q19 Wholesale Cannabis Sales in Puerto Rico

"The intention is to allow extracts to be used in medicine, cosmetics and food and support hemp as a cash crop," Tares Krassanairawiwong, Secretary-General of the Food and Drug Administration in Thailand, told reporters. Hound Labs raises \$30 million to support commercial development of combined cannabis and alcohol breathalyzer. Hound Labs Inc., creator of the world's first dual marijuana and alcohol breathalyzer, today announced the closing of a \$30 million Series D financing round to accelerate manufacturing and commercial availability. Intrinsic Capital Partners, which funds life science and technology-focused businesses in the emerging cannabis industry, led the round. Read More (New Cannabis Ventures)

Segra expands plant tissue culture operations into U.S. hemp market, leases Oregon production facility. Segra International Corp., an agriculture technology company, announced that it will soon begin operations in the U.S., providing plant tissue culture services to growers in the emerging federally legal U.S. hemp market. This new operation represents the company's premiere entry into the U.S. hemp space and will be developed concurrently with the company's Canadian cannabis strategy. Colorado to require mycotoxin testing for cannabis concentrates. Colorado regulators will require medical and recreational marijuana concentrates to be tested for mycotoxins beginning in September. The state's Marijuana Enforcement Division sent a notice to the industry that, beginning Sept. 15, any concentrates made from marijuana on or after that date that failed microbial contaminant testing will be tested for mycotoxins. Researchers from the University of Pittsburgh announced that they have developed a "cannabis breathalyzer" that can measure the amount of THC in a user's breath. The University of Pittsburgh's prototype uses carbon nanotubes, 100,000 times smaller than a human hair. According to breathalyzer's designers, any THC molecules in a driver's breath will bind to the surface of these fibers and change their ability to conduct electricity. This change in the electrical currents' speed then signals that THC is present. "The semiconductor carbon nanotubes that we are using weren't available even a few years ago," Sean Hwang, lead author on the paper published in ACS Sensors, wrote in a press statement. Plaintiffs Richard Komaiko and Marcie Cooperman filed the litigation against the Denver-based cannabis industry business service provider in federal court in the Northern District of California June 28 over alleged repeated violations of federal and state telemarketing legislation. The lawsuit alleges that Baker's involvement in sending telemarketing text messages violated the federal Telephone Consumer Protection Act (TCPA) and California's Unfair Competition Law (UCL). 

The suit, filed in Orange County Superior Court of California, contains a host of salacious allegations, including one that founder and CEO Robert Taft ran an unlicensed marijuana grow operation in Sonoma County. SUSTAINABILITY

Illinois sets strict energy efficiency rules for cannabis growers. Both recreational and medical cannabis growers in Illinois will have to meet high standards for their energy and water use. A state law signed by Gov. J.B. Pritzker in June places limits on the amount of water and electricity growers can use, as well as setting requirements for water runoff and wastewater. "This is a high-resource-use industry, and it doesn't have to be," said state Rep. Kelly Cassidy, D-Chicago. "Illinois can show the way to do it in a better way." The legislation's sustainability requirements for growers is among the strictest in the nation, according to Sam Milton, a consultant at Climate Resources Group, which helps businesses, regulators and other organizations pursue climate-friendly business practices. 
